OFFICE ORDER

Sub: Offer of Appointment of Instructors on full time contractual basis for the Academic Session 2011-12.

The Competent Authority is hereby pleased to offer of appointment to the post of Instructor on full time contractual basis for the academic session 2011-12, for conducting theory and practical classes in the Govt. Industrial Training Institute/ Basic Training Centre, Delhi / New Delhi on the following terms & conditions :-

1. The appointment will be on PURELY CONTRACT BASIS till Feb. 2013 or as per the requirement/ availability of trainees of the concerned trade in ITI/BTC or till such time the posts are filled on regular basis through DSSSB, Govt. of NCT of Delhi, whichever is earlier. This will not vest any right to claim for regular appointment in the department or for continued contractual appointment.
2. The remuneration to the Instructors engaged on full time contractual basis will be Rs.16470/month (consolidated) and no charges other than this will be paid. The same will be directly linked to performance of teaching duties and work actually performed.
3. The Principal concerned can terminate the appointment at any time without assigning any reason or giving any notice during the contract period.
4. The candidate shall have to give one month notice or deposit an amount equal to one month remuneration if he / she wish to terminate the contract immediately.
5. The candidates shall assist the concerned Principal in any assignment given by him / her.
6. The candidates has to deposit the original academic & technical certificates and certificates of SC/ST/OBC/PH etc. for complete session or till the termination of the service in the Institute as guarantee against the security of Tools, Equipments and Machinery issued for training purposes.
7. If any declaration / information furnished is found false or if any material fact suppressed willfully, the contractual appointment will be terminated forthwith.
8. The final appointment order will be issued by Principal concerned only if sufficient number of trainees are available in the trade for which candidates is sponsored by D.T.T.E. (NCT) and after checking the eligibility criteria as per Recruitment Rules with age limit (18-65 yrs.).
9. The appointee shall not be entitled to any benefits of Provident Fund, Pension, Gratuity, Medical Attendance & treatment, Govt. Residential Accommodation or H.E.A. in lieu thereof or any other benefits and concessions admissible to Govt. servants.
10. This appointment will not confer up on the appointee any right or claim for regular appointment to the post and an undertaking will have to be furnished by the appointee that no court cases will be filed during or after completion of the contract period for seeking any regular appointment.
11. The appointee shall be entitled for casual leave of 8 days & 2 R.H. with the prior approval of the Principal in a year in addition to Government holidays. No other leave / vacation with or without pay will be admissible under any circumstances.
12. The candidates has to give the following undertaking at the time of Joining :-
 - (i) The candidate is not engaged during current academic session 2011-12 in any other ITI/BTC under the Department of Training & Technical Education, GNCT of Delhi.
 - (ii) The candidates will not have any claim on regular post and should not approach the Court for establishing the claim towards the regular post.

The terms and conditions laid down would be amended from time to time by the Department of Training & Technical Education, GNCT of Delhi, when required.

If you agree to accept the above terms and conditions, you should report to the Principal, ITI / BTC **SIRIPORE** on or before 27/1/2012 between 9.00 A. M. to 4.00 P.M. failing which the candidature will be treated as **CANCELLED** and no further communication will be entertained in this regard.
