3.1 At today's hearing, on 28/4/2016, Sh. Sanjeev Gupta, AO (Vigilance), TTE filed a dated 26/4/2016 (in duplicate, a copy of which was given to the appellant), in response queries posed by the appellant under Delhi RTI Act, 2001.

4. Directions of the PGC

It is clear that the RTI Branch of TTE is not handling PGC cases properly. It is informed that no action has been taken on letter dated 24/7/2012. Fresh copy of the complaint be given to AO (Vig.), DTTE by the appellant. As regards query No. 3, Sh. M. N. Sha Principal, ITI Pusa, on 24/2/2014, stated before the Commission that he has not submitted report dated 11/8/2011. Accordingly, the Appellate Authority / PGC cannot proceed further in matter. As such, the appeal case is ordered to be disposed of before the Appellate Authority / PGC.
