No male candidate who has more than one wife living or no female candidate who has married a person already having a wife living shall be eligible for appointment in case of direct recruitment, provided that the Administrator, Delhi, may, after consulting the Director, Delhi, exempt any such candidate from the operation of this rule.

If the Administrator is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing, relax any of the provisions of the rules with respect to a class or category of persons/posts.
