

Subject: Harassment by my employer Dept. of Training & Technical Education (DTTE), Delhi

Namaskar,

Being a common man I lost all hope from previous govts but now under your able stewardship I can see a silver lining and hope that justice shall be meted out to me so I gather courage to apply to your kind honor that my employer Dept. of Training & Technical Education (DTTE), Delhi Govt is harassing me since long regarding NOC for acquiring PhD Part-Time (PT) from MD Univ, Rohtak, Hry and LLB evening 6:15 pm to 9:15 pm from Delhi Univ during my present job though copy of NOC & information is already submitted to DTTE. My details are:

Qualification: Ph.D, MBA, BE (compt Engg)/ LLB (Delhi Univ)

Present Post: selected by UPSC (Union Public Service Commission) as Lecturer, Group- A (Gazetted) working at GND Polytechnic under DTTE, Delhi Govt. since 21/09/2000.

Experience: selected by HPSC (Haryana Public Service Commission) as Lecturer, Group-B(Gazetted)worked from 03/03/97to21/09/2000 in Haryana Govt. selected as Asst Director for two tenures on deputation in AICTE (All India Council for Technical Education) under MHRD and worked in various capacities at national level between Feb 2004 to 2010.

The following communications to and from DTTE have been held so far:

05/12/03	NOC issued by AICTE Vide letter no 101-91/B1/ Adm(s)/2001 (where I was on deputation) for Ph D Part time (PT) from IIT Delhi and copy sent to my parent employer DTTE for information & necessary action which never objected to NOC.
02/08/04	NOC issued by AICTE Vide letter no 101-129/1/ Adm(s)/2003/ 343 (where I was on deputation) for Ph D (PT) degree from MD Univ, Rohtak Haryana and a copy sent to my parent employer for information which never objected to this NOC.
27/05/09	NOC issued by AICTE Vide letter no 101-255/B1/ Admn(s)/2006/100 (where I was on deputation) for evening classes 3 year LLB degree from MD Univ, Rohtak Hry.
15/05/10	I submitted my application to AICTE (where I was on deputation) for information and to seek permission for 3 year LLB degree evening classes 6:15 pm to 9:15 pm ie after working hours from Delhi Univ with request to forward my application to my parent employer DTTE.
31/10/11	Vide Diary no 263/GNDP dated 01/11/11 I submitted information to my employer DTTE that I am pursuing 3 year LLB degree evening classes 6:15 pm to 9:15 pm ie after working hours from Delhi Univ from 2010 session.

11/11/11	My letter dated 31/10/11 was returned in original by Principal of my Polytechnic raising queries whether I took study leave and name of the university for LLB.
14/05/12	Vide Diary no 1263/GNDP dated 21/05/12 I informed DTTE that I have completed Ph D degree and it may be considered for promotional and career benefits.
30/07/12	Vide Diary no 1939/GNDP dated 03/08/12 I replied to the queries raised by the Principal on 11/11/11 and clarified that study leave is not required because LLB classes are held in evening 6:15pm to 9:15 pm ie after working hours at Delhi Univ.
14/08/12	My letter dated 30/07/12 was returned to me in original by Principal of my Polytechnic raising queries whether I took permission for LLB before pursuing it and demanding copy of the permission.
12/09/12	Vide Diary no 2231/GNDP dated 12/09/12 I replied to the queries raised by Principal on 14/08/12 and supplied copy of my application dt 15/05/10 submitted to AICTE to seek permission for admission in LLB evening and requesting AICTE to send it to DTTE for information and necessary action. As on 15/05/10 I was not on rolls of DTTE as I was on deputation since 14/02/2006 in AICTE on 2 nd tenure.
25/07/14	Vide Diary no 2456/Ps/TTE dated 28/07/14 of DTTE and copy to Principal GND polytechnic I sent reminder to DTTE that my Ph D degree be considered for promotional and career benefits.
04/08/14	My letter dated 25/07/14 was returned to me in original by Principal of my Polytechnic demanding NOC for Ph D.
13/08/14	Vide Diary no 359/GNDP dated 14/08/14, I supplied the copies of NOC for Ph D degree issued by AICTE where I was on deputation.
07/04/15	Vide letter no F.1/839/2000/ TE/ AD/ 348 my employer DTTE has again demanded NOC for Ph D and LLB courses.

I started Research work for PhD (PT), MD University, Rohtak, Haryana in 2008 and registration process was done in 2008-09. I completed research work in 2010 and submitted thesis in 2011 and degree was awarded in 2012. I took admission in 3 year LLB (evening classes 6:15 pm to 9:15 pm) at Delhi University in 2010 and completed in 2014.

The text from the CCS Rules regarding joining of educational institutions by govt servants outside normal office hours is reproduced **here:** "Ordinarily, there can be no objection to the pursuit of Knowledge by Govt servant in their leisure hours". Since Teaching and Learning is my basic job so pursuing knowledge after working hours is no violation of norms.

Therefore I request your kind honor to direct the concerned authorities to stop harassing me in the name of NOC.

'Swaraj' seems to be a Mirage as the prevailing 'Redtapism' and autocratic Beurocracy the legacy of the British era is bound to kill the fundamental right of Learning and pursuing Knowledge of 'Aam Admi' like me whose basic job is 'Teaching and Learning'.
