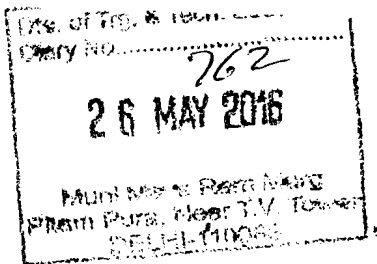

Sub : Information Required Under RTI Act 2005 – In the matter of Irregularities in allotment of Reserve Seats for Defence Category in B Tech Courses

Sir,

The H'ble Supreme Court dated 14 Aug 2003 given in the matter of Islamic Academy Of Education Vs State of Karnataka & others, which judgement is reported as (2003) 6 SCC 697, for Defence Category, 5% seats for each programme are reserved for Widows/Wards of personnel of Armed Forces in the order of prescribed category. It mentions of all the seven categories in the priority and also explain the need of making a special category which is to be counted over and above with other Reservations provided by Constitutions of India.

"Recognising the valuable services rendered to the Country by Defence Personnel, Government attaches the utmost importance to their Welfare and Rehabilitations of Defence Personnel, who have remained away from their homes for most of their Service Careers cannot satisfy the domiciliary restrictions. Consequently they are virtually state less."

We are concerned with admission into DTU, Delhi as far as the Govt of NCT Delhi it has issued orders dated 10 Feb 2004, which contains policy guidelines on admission and reservations of seats covering the AICTE approved courses/institutions affiliated to Indraprastha University.

2. Have you ever issued any special Instructions/Orders to DTU, Delhi for not following OVER and ABOVE reservations policy for this special Category, because for the quota like NRI/Topper, DTU following over and above formula, please explain why such disparity to this special category where all guidelines from HRD Ministry/H'ble Supreme Court/UGC are bent on priority basis?
3. Does any special instruction was issued to NSIT, IIIT, GGSIPU and IGDTUW to follow Over and above formula while making reservations to this special category?
4. Does your Department is aware of, by implementing such formula with this Special Category DTU have reduce the quota from 5% to 2.5% (Approx). If yes, than please provide the copy of order?
5. If above question are abide with rules and regulations, in future any instructions or orders will be issued to DTU for amendment of such procedure, please provide the copy?
