No. 1, 2 & 3.	<p>Attention is invited towards CIC decision in the matter no.CIC/BS/A/2014/001869+1885+2107+2020+2189+2190+2191/8241 dated 03.08.2015 filed by Mohmad Iqbal Soharatali Ansari wherein the CIC referred decision of the Supreme Court of India in the SLP (C) No.27734 of 2012 (Girish R Deshpande vs CIC and others) in which it has held that:-</p> <p><i>"The performance of an employee/Officer in an organization is primarily a matter between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression personnel information, the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which could cause unwarranted invasion of the privacy of that individual"</i></p> <p>The Supreme Court further held that such information could be disclosed only if it would serve a larger public interest. The information sought by the Appellant in this case is about some complaints made against a government official and any possible action the authorities might have taken on those complaints. It is, thus, clearly the kind of information which is envisaged in the above Supreme Court order. Therefore, the information is completely exempted from disclosure under the provisions of the RTI Act.</p> <p>As per the ratio of the above cited decision information relating to complaints against public servants and action taken thereon is exempted under Section 8(1)(j) of the RTI Act unless larger public purpose is demonstrated.</p>
