

In this regard the following information have been sought:



1. The description of the dispensary and the ITI institute which has been described in the advertisement wherein the Hon'ble CM, Delhi claims to have saved Crores of Rupees.
2. The complete information, location, budget of the dispensary which has been constructed in just Rs. 20,00,000/- as claimed in the advertisement by the Hon'ble CM, Delhi and the ITI in which Rs 8 crore for the construction of the ITI have been saved.

the information regarding the tender passed for constructing the dispensary as claimed over the FM Radio, New Delhi, initially passed as discussed in the advertisement and the savings made in the construction of the dispensary constructed in the tenure of the AAP Government.

4. The information as to when the construction of the dispensaries started, when it was completed and the last payment that was made by the AAP Government towards the construction of the dispensaries being described in the Advertisement.
5. The information regarding how much payment was made towards the construction of the same flyover during the tenure of the AAP Government.
6. The information whether the tender was passed by the present AAP Government or the preceding UPA government in Delhi.
7. The information as to whether the payment which was given for the construction was less than the initially agreed amount. (tender amount).
8. The information regarding the manner in which the present AAP Government saved the amount of Rs 4.80 crore as claimed in the advertisement in the construction of the dispensary; and Rs 8 crore in the construction of the ITI.
