- 3) Is Delhi Government aware that Tamil Nadu Govt. had established Aravanis Welfare Board and identified 4294 Kinnars and wherein the Board has distributed ID cards to 3328 aravanis so far and Ration Cards have been issued to 1544 Transgender, House Patta issued to 1053 Transgender, and tailoring machines distributed to 102 Transgender, Insurance Certificate given to 660 Transgender Community people so far?
  - a. Does Delhi Government have separate Welfare Board for transgenders to look into their specific problems and resolve their issues?
  - b. When is going to Delhi Government to establish such a board?


