1. Whereas Sh. Mansa Ram Jatav, Lab attendant (Retd.) has requested vide his representation dated 16/07/2014, 14/11/2015 and 03/12/2015 vide which he requested to grant ACP scheme w.e.f. 09/08/1999.
2. Thereafter Sh. Mansa Ram Jatav, Lab attendant (Retd.) had filed OA No. 2426/2015 in the Hon'ble CAT and prayed for granting 1st & 2nd up-gradation to the applicant from the date of completion of 12/24 years of service with all arrears of pay and 9% interest w.e.f 09/08/1999.
3. Whereas in the said O.A. No. 2426/15 titled Sh. Mansa Ram Jatav, Vs. GNCTD & others, the Hon'ble CAT vide order dated 09.07.2015 (received in E-1 Branch on 12.08.2015) has directed at admission stage itself that the Directorate of Training & Technical Education, ONCT Delhi to consider the representation of the applicant and to pass appropriate speaking and reasoned order thereon within 90 days from the receipt of this order, in accordance with law.
4. And whereas, as per the OM dated 09/08/1999 issued by the DOPT, Govt. of India, the ACP benefits are subject to the fulfillment of promotional norms. An official having requisite qualification for promotion to the next promotional post can only be granted benefits under the said scheme.
5. And Whereas Sh. Mansa Ram Jatav, Lab attendant (Retd.) has only 8th passed as per the record available.
6. Whereas as per RR the requisite qualification for grant of ACP for promotional post was Matric with science and two-years experience in Laboratory/workshop or diploma in Medical laboratory Technology. While Sh. Mansa Ram is only 8th Pass as per records.
7. Moreover, DTTE had already processed representations of Sh. Mansa Ram and vide communications dated 25/01/2016 and 03/03/2016 informed him of grounds of his non-eligibility for grant of ACP scheme. It is clear that Shri Mansa Ram Jatav does not have requisite qualification for getting promotion as per RR.

Now therefore, in compliance of the order dated 09/07/2015 passed by the Hon'ble Tribunal, New Delhi in O.A. No. 2426/2015 and in the matter of Sh. Mansa Ram Jatav, v/s GNCT of Delhi & others, the case of Sh. Mansa Ram Jatav, Lab Attendant (Retd.) was considered and found ineligible in terms of OM dated 09/08/1999. The issues raised by him in the O.A. are accordingly disposed off.

ORDER (ORAL)

Mr. V. Ajay Kumar, Member (J) :-

Heard the learned counsel for applicant. The applicant, a retired Lab Attendant is aggrieved by the action of the respondents in not granting him 1st and 2nd financial upgradations inspite of making repeated requests. He has filed the present OA seeking the following reliefs :-

(a) To declare the action of respondents in not granting 1st & 2nd financial upgradation to the applicant as illegal and arbitrary and direct the respondents to grant the 1st & 2nd Financial Upgradation to the applicant from due date with all arrears of pay.

To direct the respondents to grant 1st & 2nd up-gradation to the applicant from the date of completion of 12/24 years of service with all arrears of pay.

~~to Direct the respondents to grant the pay scale of Rs.4000-6000 & 5500-9000 to the applicant from 09.08.1999 with all arrears of pay and 9% interest.~~

- (d) To allow the O.A. with exemplary costs and interest on the arrears of pay.
- (e) Pass such other direction or directions order or orders as this Honble Tribunal may deem fit and proper to meet the ends of justice.

2. It is submitted that the applicant made number of representations for redressal of his grievances. However, though the respondents vide Annexure-A/5 and A/6 recommended the case of the applicant to higher authorities but no final orders have been passed till date.

3. In the circumstances, the OA is disposed of, without going into the merits of the case, at the admission stage itself, with a direction to the respondents to consider the Annexure-A/1 representation of the applicant read with Annexures A/5 and A/6 and to pass appropriate speaking and reasoned order thereon within 90 days from the date of receipt of this order, in accordance with law. No costs.
