8. From the aforesaid chart, it is clear that the submission of the respondent that the Craft Instructors (stenography) is an isolated post is factually incorrect. S the other hand, the Vocational Instructors are the fer cadre for Craft Instructors. Even otherwise, as pr standard pay scales contained in CCS (Revised) Par 2008, the revised pay scale of Rs. 5500-9000 in P' 9300-34800 with grade pay of Rs. 4200. The revised pay scale is Rs. 9300-34800 with grav We, therefore, do not find an 4600. whatsoever on the part of the respondent revised pay scale of Rs. 9300-34800 wit

4200 in PB-2 to the applicants. On the other hand, they should have been given the same 'V scale of Rs. 9300. 34800 with grade pay of Rs. 4600 'ven to the Craft Instructors of other trades.

In the above facts and circumstance allow this OA. We hold that there shall be case, we the pay band of Craft Instructor (stenograpity in Craft Instructors of other trades working in 1,15 Delhi and all of them are entitled for the same grac Rs. 4600. Accordingly, we direct the respondents to the pay bank of Rs. 4600 to the applicants also, as t have granted to other similarly placed Craft Instructors i. other trades. Further, the respondents shall work out the arrears of pay and allowances which are payable to the applicant. Even though, the applicants have sought payment of interest @12% p.a. on the arrears of pay from the due date till such payments are made, we follow the directions of this Tribunal in its order in OA-1233/2009 (supra) and direct the respondents to pay interest @9% p.a. to the applicant from the date the amount of arrears became due till payment thereof. The aforesaid direction shall be complied with, within a period of two months from the date of receipt of a copy of this order. There shall be no order as to costs.

- 7. On the other hand, the respondents would submit that they have fully complied with orders of this Tribunal by passing a speaking order on 20.11.2012 itself and hence no contempt is maintainable against them. It is further submitted that the present contempt is not maintainable as the same was filed beyond the period of limitation.
- 8. This Tribunal while disposing of OA No.3371/2012 only directed the respondents to examine the cases of the applicants keeping in view the orders of this Tribunal and if the applicants found similarly placed like the applicants in other OAs, they be given the same benefits; else they shall pass priate speaking orders. Accordingly, the respondents and speaking orders on 20.11.2012 stating that the context are not similarly placed by giving certain reasons.
