The Department has received the representation dated nil from the craft-Instructors (holding-Degree in Engineering) of different trades working in different Govt. ITIs/BTC for inclusion of the names of 25% Engineering Degree Holders from seniority list of Craft Instructors in current list of twenty four Craft Instructors mentioned in letter No. F.32 (5)/Trg. Admn./2014/83 dated 07/02/2017 for promotion to the post of Group Instructors in all Government ITIs of Delhi.

The representation has been examined in view of the existing recruitment rules for the post of Group Instructors etc. (notified on 29th Oct. 2013) as well as Craft Instructors etc. (notified on 15th Nov. 2016) and rejected as there is already 100% promotional quota for Degree/Diploma Holders w.e.f. 28.08.2003 and there is no separate provision for promotion of 25% quota for Craft Instructors holding Engineering Degree in existing RRs of Group Instructors etc. However, as per RRs of Group Instructors etc. the requirement of qualification is not applicable for those appointed on or before 28.08.2003.

This issues with the approval of Director, TTE.



Said letter contains list of twenty four Craft Instructors without containing names of 25 % Engineering Degree Holders which is contrary to the Norms"Career progression for Instructors" of 7th January 2016 MSDE-19/03(10)/2015-CD Government of India Directorate General of Training Ministry of Skill Development &Entrepreneurship (MSDE) hereinafter called as DGT, MSDE.Operating part of these norms is as under

i)For promotion to the post of Principal and Group Instructor 25%cf post in promotion quota will be reserved for degreeholders. Remaining 75% will be filled on seniority basis considering all i.e. Degree(remaining not covered under 25%)/Diploma/CTS holders.(ANNEX-A)

We are unanimous on this point that all Norms issued to State Directorates by **DGT**, **MSDE**are followed in all Industrial Training Institutes and by Norm **Subject: Modificationin accreditation criteria for granting accreditation to ITIsMSDE-** 19/03(1)/2015-CD Government of India Directorate General of Training Ministry of Skill Development & Entrepreneurship (MSDE), normunambiguously state at paragraph 3 as under
