6. Has any FIR been lodged, if yes, provide the FIR No. and a certified copy of the FIR.
7. If no, please inform, Did the G.B. Pant Engg. College filed any case to Police for enquiry / verification.
8. If yes, please provide the certified copy of the correspondence.

The above informations are required in Public interest.

I have to state that the information sought does not fall within the exemptions contained in section 8 of RTI Act-2005.



**FIRST APPELLATE AUTHORITY UNDER SECTION 19(1) OF THE RTI ACT**

**Facts of Appeal:-**

1. In connection with the RTI Application bearing RTI ID NO. 246 dated 07/06/2018 of Sh. Lakhvinder, the PIO/APIO GBPEC vide letter no. F.NO. 1H(51)/RTI/Admn./GBPEC/2018/ 3286 dated 02/07/2018 had replied to the applicant Sh. Lakhvinder that no such records are available in this department.
2. The applicant Sh. Lakhvinder was not satisfied with the reply furnished by the PIO/APIO and had filed an appeal vide diary no. 1962/Estt. dated 08/08/2018 to the First Appellate Authority. The ground of appeal raised by the appellant are:-  
The information was in public interest since Mr. O.P. Sharma, Principal of the Institute had issued a public notice in the H.T. on 25/08/2011.
3. With reference to his appeal the applicant was requested for a personal hearing in the office of the First Appellate Authority, GBPEC on 12/09/2018 along with the PIO/APIO.
4. During the appeal the applicant again requested to furnish the requisite information pertaining to Sh. Rakesh Bhatia S/o Late Sh. B. L. Bhatia, since the issue pertains to the public interest. During the personal hearing the appellant has also produced a public notice published by G. B. Pant Engineering College in the newspaper to establish the public interest on the above issue.



5. Sh. Madan Lal(PIO,GBPEC) or Ms. Meenakshi Das(APIO,GBPEC) was not present during the personal hearing to contest the claim of the applicant although the hearing notice was served to them well in advance.

**Order**

In view of the above stated facts, it is directed that Sh. Madan Lal (PIO, GBPEC) furnish the requisite information to Sh. Lakhvinder Singh or forward the application of the appellant to the concerned Public Authority dealing the above issue.

Accordingly the appeal is disposed off.

Appeal against this order lies with the Central Information Commission, August Kranti Bhawan, Bhikaji Kama Place, Delhi-110066 within 90 days from the date of receipt of this order.
