Sh. P.C. Garg, Craft Instructor (C.I.), Electronics, was transferred from ITI Nand Nagri 213. to ITI Pusa and Sh. Y.R.Mehta, C.I. was transferred in his place.

- During the charge taking / handing over process Sh. Y. R. Mehta refused to take 214 charge of 27 items, citing reason that make /specification of these items did not match with the items entered in the stock ledger.
- 215. To sort out the issue, a Technical Expert Committee was constituted at institute level and it submitted its report finding therein that 27 items, which are physically present, differ in the make/specification as mentioned in stock ledger.

216. The matter was referred to TTE(HQ) and it was advised that the matter is within the competency of Principal of the Institute and it can be resolved at institute level. The matter was again forwarded to DTTE, HQ with submission that Principal/HOD being Store officer is not authorized to alter the make/specification of items in store ledger without the approval of higher authority. She further added that most of the items were procured before year 2000 and they are not listed in current/revised syllabus of trade Electronics Mechanic and do not serve the purpose of training and are at the verge of condemnation. She also requested to authorise her to make amendment in entries of 27 items (make/specification) which are physically present in the store ledger for the disposal of issue pending since long.

217. Accounts Branch, DTTE, observed that as per GFR there was no such provision to change the specification of the items at later stage and further advised that "any amendments of specification of the items may be made in stock register as per bills or from the items already existing in the institute. Specifications of existing items should be the same as per bills (which were kept in the office copy in the Accounts Branch) of procurement and supply order." (para 76 page 14/N).

218. In response, Principal ITI Nand Nagri informed that the bills in question could not be traced out and therefore it is not feasible to amend specification of the items in stock register as per bills or from the items already existing in the institute. DCA observed that the variations have been highlighted by the Committee but not indicated whether the items present physically are of the same specifications and utility as entered in the ledger. 1100年期時代的1月1月時代1月1日日

2/9 in the light of above observation the committee constituted at institute level reexamine the matter and observed that :

1. The items under the charge of Sh. P. C. Garg, C.I. Electronics Mech. which are under dispute for difference of physical available items with the store record

2. As deemed in the office order it is stated that these items except SI. No. 17 are of no use for electronic trade as per the new revised syllabus.

As per the list, the items do not tally with the store ledger of the Institute. 3 (refer page 105/C)."

220. Further AO (HQ)-observed that "if the specification of existing items is not the same with the items entered in the stock register, the amount of Rs. 2, 40,155/- as proposed may be recovered from the concerned official."

221. A meeting was convened in the chamber of Admn. Officer (Trg.) and in the meeting it was decided to constitute an independent committee (comprising Lecturers from Polytechnics) to inquire into the matter.

(I) For first group of items, where items S.No. 1 to 9, 10 to 17 and 21, 22 included, the committee in general recommended that "As per stock ledger entry" there is no difference.

(ii) For second group (item S.No. 18, 23, 26&27) where there is a difference in make of the item committee recommended that "there is no difference in specification & purpose of utility is same to serve the training. As per stock ledger entry there is difference in make of the item, this item is functionally wise same."

(iii) For third group (item No. 16, 19& 20); the committee recommended that "It was same handed over by previous faculty to Sh. Garg on 18.05.2010."

223. Comments of Accounts Branch, DTTE(HQ) and Principal, ITI, Nand Nagari were sought on this report. Accounts Branch (HQ) commented that "the difference in make & model of the stock may only be considered if it is mentioned in the original bills, but, in the present case, original bills are not traceable. Moreover, there is no provision mentioned in the rules for granting of relaxation for making any alteration/change in stock."

224. On this report Principal, ITI, Nand Nagri observed that "nothing adverse is noticed".

226 From foregoing, it is evident that:

(i) The committee formed at institute level observed that these items except SI. No. 17 are of no use for Electronic Trade as per new syllabus.

(ii) The independent committee found no noticeable discrepancy in the items in question (including item No. 17) and where the committee found any difference in make it termed it as "item is functionally same".

(iii) Accounts Branch (HQ) observed that there is no provision mentioned in the rules for granting of relaxation for making any alteration/change in stock."

(iv) ITI, Nand Nagri observed that "nothing adverse is noticed".

2.26. In this regard it is worth mentioning that much time and effort has been put in for resolving this issue. Detailed examination at various levels/Committees have not indicated any malafide intention. Therefore, following is proposed:

(i) Principal of the Institute may be allowed to make amendments in entries (in r/o make / specification) of 27 items in the store ledger and official concerned who is to take charge from Sh. P.C. Garg, C.I., may be directed to take charge of these 27 items on, as and where is basis and then process of condemnation may also be initiated.

(ii) The cost of item No. 17 (as per rules) may be recovered from Sh. P.C. Garg,C.I.


