
This has reference to letter No. RTI Online/TTE/DOPOT/R/2019/60029/783 dated 08.05.2019 filed by Sh. Ramesh Kumar Mumukshu. In this regard, the point wise reply of RTI application as under:

Point no. 1 & 2: The service matter of an employee/officer in an organization is primarily a matter between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression "personal information" the disclosure of which has no relationship to any public activity or public interest, further, the interpretation of query raised is not covered under RTI ACT. You may refer the AICTE notification issued time to time in this regard.

Point no. 3: The requisite information is not covered under the definition of information as per section 2(f) of RTI Act 2005.
