

Whether it is correct that M/S Well Protect Manpower Services Pvt.Ltd. was awarded contract for providing security services in 1)Ambedkar Institute of Technology, 2)Bhai Permanand Insitute of Business Studies,3)G.B.Pant Institute of Technology,Okhla, 4)Meera Bai Institute of Technology under "cluster-system bid" w.e.f. 1-8-2015 to 31-7-2017 i.e. for a period of two (02) years . A copy of said contract order may please be furnished?.
2. Please intimate whether incremental enhanced/revised wages were allowed during the period of above said contract for providing security services as per tender ?.
3. Please intimate whether the Extension of contract was granted, if yes, upto which date.? Photo copy of the Extension Orders may please be supplied?
4. Please intimate whether enhanced/revised Minimum Wages granted by Labour Deptt.,GNCT of Delhi were made applicable to the said security agency from time to time.?
5. Please intimate whether it is correct that the Principal, Ambedker Institute of Technology, vide their letter No. F-4(55)/Part file/2015-16/1709, dated 31-10-2018 has directed the said agency to submit their bills as per revise/.enhanced rates w.e.f. 1-4-2018 in view of Delhi Govt.Cabinet DecisionNo.2652(item No.2) dated 18-10-2018, if yes, then please intimate whether payment has been released to the said agency from 1-4-2018 onwards as per revised/enhanced Minimum Wages upto which period.
6. Please also intimate, whether the agency has submitted the bills on revised/enhance rates w.e.f. 1-4-2018 onwards in each & every Institutions alongwith ECRs of EPF,ESI & proof of payment through ECS/.RTGS?
7. Please intimate whether payment has been released to the said agency by all the 04 Institutions from 1-4-2018 onwards as per revised/enhanced Minimum Wages,if yes, upto which period.
