



Sh. Kishan Chand, G.I. is hereby directed to submit his option/preferences for posting to the undersigned within 03 dayes from receipt of this communication to proceed further in the referenced matter."

मेरे पति श्री किशन चन्द जी को यह ह्रासमेन्ट और यातनायें इसलिये दी जा रही हैं। क्योंकि मेरे पति ने विभाग DTTE में हो रहे करोड़ों रूपयों के भ्रष्टाचार का ठोस सबूतों के साथ DTTE में मिलीभगत द्वारा हो रहे भ्रष्टाचार का खुलासा किया है। तथा भ्रष्टाचारीयों की भी पोल खोली। जिसके कारण भ्रष्टाचारीयों की मिलीभगत से मेरे पति श्री किशन चन्द जी को Transfer करके घर से बहुत दूर भेज दिया है। जिससे उनकी जानमाल का खतरा भी बढ़ गया है। क्योंकि उन्हें पहले भी हाथपैर तोड़ने की धमकी मिल चुकी है। जिसके लिये विभाग को पहले ही लिखकर दिया गया था। और इस समय तो वैसे भी उनका स्वास्थ्य दिन प्रतिदिन गिर रहा है।

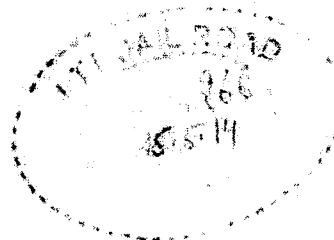

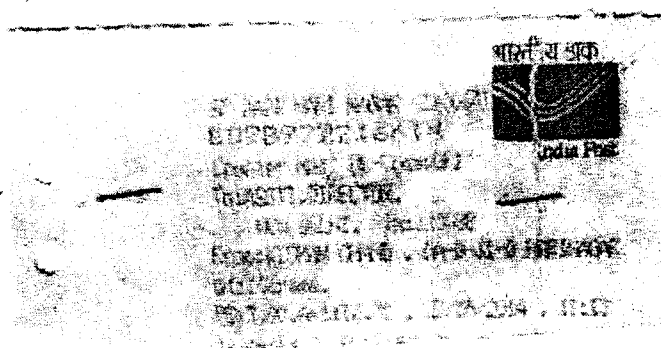
