

I have enclosed a postal order for ₹10/- addressed to Accts officer DTTC Delhi 110088.



Sir,

Kindly find enclosed herewith a copy of my letter addressed to the Principal Aryabhat Institute of Technology, Delhi 110033 dated 25-5-2016 requesting him to remove the pay disparity with Sh.P.P.Gupta (Retd.selection grade lecturer) and correct the pay fixation in my regard. I was HOD since 16-02-89 and retired on 31-01-99.

I have also enclosed the copy of the office order of the Principal ABIT dated 6-05-2016 wherein my designation has been wrongly mentioned as LECTURER instead of "HOD". The order has completely ignored my seniority over Sh.P.P.Gujta.

By awarding increment of Rs.420/- in the pay scale (Rs.1200-420-18300) on 1-01-96 to Sh. P.P.Gupta raising his pay from Rs.14940/- to Rs.15360/- and leaving my pay behind at Rs.14940/- on 1-01-96 means "Junior " drawing higher salary on the same date. This is an anomaly and disparity.

I was H.O.D since 16-02-89 and Sh.P.P.Gupta remained lecturer throughout (i.e) always junior to me.

By virtue of my seniority over Sh.P.P.Gupta I request that my pay on 1-01-96 be stepped up to Rs.15360/- at par with Sh.P.P. GUPTA and to refix my pay awarding increments w.e.f 1-01-1996.

**Sir,**

Your above order of pay fixation granting me increments w.e.f 1-2-1996 is not acceptable to me as it has ignored the fact of my seniority over the rest of other officers concerned (in particular .Sh. P.P. Gupta).

On 1-1-96 Sh.P.P.Gupta drawing a pay of Rs. 14940/- at par with me was awarded an increment of RS420/- (Scale 12000-420-18300)and his pay rose to RS.15360/- on 1-1-96 over taking my pay of Rs.14940/-, thus causing the disparity.

Sh.P.P.Gupta (Selection grade lecturer) getting more pay than me (V.Jayaraman,HOD since 16-2-89) (ie) junior getting more pay on the same date 1-1-96) than his senior (V.Jayaraman, HOD)is an anomaly causing disparity and injustice. In such cases the pay of senior is stepped up at par with his junior as per the fundamental rules of central Govt. services with a view to removing genuine anomalies.

So , I request you to step up my pay from RS.14940/- to 15360/- to bring my pay at par with Sh.P.P.Gupta (my junior) on 1-1-96.

The rest of the pay fixation in my case (V. Jayaraman, HOD) shall be as follows:
