## Office Memorandum

: Guidelines for conducting written examination for Persons with Benchmark Disabilities as per THE RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016

XII. The word "extra time or additional time" that is being currently used should be changed to "compensatory time" and the same should not be less than 20 minutes per hour of examination for persons who are allowed use of scribe/reader/lab assistant all the candidates with benchmark disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration. In case the duration of the examination is less than an hour, then the duration of additional time should be allowed on pro-rata basis. Additional time should not be less than 5 minutes and should be in the multiple of 5.

Sub: Complaint against disparity and discrimination by College of Art, Govt of NCT of Delhi with person with disability by not giving Extra time in Entrance examination for PWD and making Discriminatory criteria of qualification in entrance for Person with disability.

Sir/ Madam

With regards I have to state following request to you,

That, I Akansha Anand D/O Parmanand Address H – 1/306 Subh dham Apartment Sector 2 Rajendra Nagar Ghaziabad UP -201005, applied for the admission in the course BFA – Applied Art (2019-20), against admission notification of College of Art Govt of NCT of Delhi in offline mode and paid required fee i.e., 250 Rs to appear in the entrance exam to be conducted by the college of Art Govt. of NCT of Delhi.

That, I am suffering from 45% of disability/ deformity in both hands, (and also in thumbs, fingers.)

That, being PWD candidate I requested for extra time, as per rule for PWD aspirants, to complete my paper during entrance examination conducted by the college of Art, Govt. of NCT of Delhi, dated 30/07/2019. But I was not given extra time to complete my Paper in entrance examination. I was told," There is no such rule for Person with Disability to give extra time in examination."

That, on 15th July 2019, the Result was declared wherein only one PWD candidate has been shown as qualified in tentative list of qualified candidates, whereas there are three seats for PWD in the college. The administration of college of Art, does not show marks statement of qualified or nonqualified candidates in the result list, it only shows names of qualified candidates.

That, on 17/07/2019 my father visited the College of Art of Govt. of NCT of DELHI, and requested about merit/marks for PWD candidates but the academic cell officer said "there is no different merits for general candidates and PWD candidates ....all students have to achieve at least 50% in entrance examination to be qualified in entrance examination whether PWD or General students."

That, if there is same qualifying criteria for all students then this is clearly violation of rights of person with disability who even not given extra time in in entrance examination by the college of Art of NCT of Delhi.

That, being Person with disability I should have been given extra time in entrance examination by the College of Art, but I was denied by the college of Art of NCT of Delhi, this disparity with me is spoiling my career.

So, I request you to save my career by taking necessary action as soon as possible and provide me chance to get admission in the college of Art of NCT of Delhi.
