

ORDER

Whereas, The Hon'ble Supreme Court of India vide order dated 06.02.2013 and 18.07.2013 in WP (CRL) No. 139 of 2006 titled Laxmi Vs. Union of India and Others has given a series of direction to the Central Govt. and to States / Union Territory to regulate sale of acid and poison so as to prevent acid attacks.

Whereas, Govt. of India, Ministry of Home Affairs in compliance of their directions has directed all States and UT to take measures in this regard including steps to notify the appropriate Poison Rules under the Poison Act 1919.

Whereas, in compliance of above directions the Govt. of NCT of Delhi, Revenue Department vide public notice no. F.36(162)/Coord./Div.Com./2013/66 Dated 08.01.2014 in national dailies has already brought to the notice of public the procedure to regulate the sale & use of acid as well as the penalty which can be imposed on default which is reiterated in this order.

Whereas, the non- restricted and non- regulated sale, or use of acid as mentioned below is causing nuisance to public at large, Acetic acid(beyond 25% concentration by weight), Acetic Anhydride, Sulphuric acid (H_2SO_4) (BEYOND 5% CONCENTRATION BY WEIGHT), Hydrochloric acid (HCl) (beyond 5% concentration by weight), Phosphoric acid (H_3PO_4), Hydrofluoric acid (HF), Perchloric acid ($HClO_4$), Formic Acid (beyond 10% concentration by weight), Hydrocyanic acid except substances containing less than 0.1 per cent weight in weight of Hydrocyanic acid, Nitric acid, except substances containing less than 5 per cent weight in weight of Nitric Acid, Oxalic Acid, Perchloride of mercury (corrosive sublimate), Hydrogen Peroxide (beyond 50% concentration by weight), Formaldehyde (beyond 25 % concentration by weight), Phenol (beyond 3% concentration by weight), Potassium Hydroxide except substances containing less than 2 per cent weight of Potassium Hydroxide, Sodium Hydroxide except substances containing less than 2 per cent weight in weight of sodium Hydroxide.

Whereas, it has been noticed that there is an emergent need to take preventive and corrective steps to curb the nuisance of non-regulated sale of acid and poisons which is becoming a cause of grave concern and nuisance to general public.

Whereas, it is brought to notice of all chemical sellers that the sale of these acids over the counter is completely prohibited except in the manner as mentioned hereunder:



1. The seller shall maintain a log/register as per format in annexure-I enclosed recording the sale of acid which will contain the details of the person(s) to whom acid(s) is/are sold and the quantity sold.
2. No acid shall be sold to any person who is below 18 years of age.
3. All sellers shall sell acid only after the buyer has shown:
 - a) A photo ID issued by the Government which also has the address of the person.
 - b) Specifies the reason/purpose for procuring acid.
4. All stocks of acid must be declared by the seller with the concerned area Sub-Divisional Magistrate (SDM) within 15 days of this notice in the format enclosed as annexure-II.

Whereas, the educational institutions, research laboratories, hospitals, Government Departments and the departments of Public Sector Undertakings, who are required to keep and store acid, shall strictly follow the following guidelines:

1. A register of usage of acid shall be maintained in the enclosed format as Annexure-III and the same shall be filed with the concerned SDM in format as annexure-IV.
2. A person shall be made accountable for possession and safe keeping of acid in their premises.
3. The acid shall be stored under the supervision of this person and there shall be compulsory checking of the students/ personnel leaving the laboratories/ place of storage where acid is used.


Whereas, it is also brought to the notice of all concerned that in case any undeclared stock of acid is detected, the concerned SDM will confiscate the stock and suitably impose fine on such seller up to Rs. 50,000/-.

And whereas, the concerned SDM is also empowered to impose fine up to Rs. 50,000/- on any person who commits breach of any of the above directions.

And whereas, since order cannot be served upon all concerned individually, the same is being passed ex-parte against all concerned in Public interest. A copy of the order shall be published at the notice board of District Magistrate, New Delhi, all Sub-Divisional Magistrate concerned & Tehsil office concerned for knowledge of general public.

Now, therefore, in exercise of the powers vested in terms of Section 1 (b) of Section 133 of Code of Criminal procedure read with the direction given by Govt of NCT of Delhi vide public notice no. F.36(162)/Coord./Div.Com./2013/66 Dated 08.01.2014 published in leading dailies under the Poison Act, 1919, it is hereby ordered that the sale of Acid without following the above norms shall not be allowed in the area of jurisdiction of District New Delhi except as provide in the law and in the manner so prescribed herein. Any person or agency or institution found violating this order shall render him self liable for action under section 188 of Indian Penal Code read with these directions as also mentioned in this order above.

1. Acetic acid (beyond 25% concentration by weight),
2. Acetic Anhydride, Sulphuric acid (H_2SO_4) (beyond 5% concentration by weight),
3. Hydrochloric acid (HCl) (beyond 5% concentration by weight),
4. Phosphoric acid (H_3PO_4),
5. Hydrofluoric acid (HF),
6. Perchloric acid ($HClO_4$),
7. Formic Acid (beyond 10% concentration by weight),
8. Hydrocyanic acid except substances containing less than 0.1 per cent weight in weight of Hydrocyanic acid,
9. Nitric acid, except substances containing less than 5 per cent weight in weight of Nitric Acid,
10. Oxalic Acid,
11. Perchloride of mercury (corrosive sublimate),
12. Hydrogen Peroxide (beyond 50% concentration by weight),
13. Formaldehyde (beyond 25% concentration by weight),
14. Phenol (beyond 3% concentration by weight),
15. Potassium Hydroxide except substances containing less than 2 per cent weight in weight of Potassium Hydroxide,
16. Sodium Hydroxide except substances containing less than 2 per cent weight in weight of sodium Hydroxide.
