This department had circulated to all departments relevant to the subject, a circular, appointed on or prior to 31.12.2005, vide letter No. 14(2)/2/Class IV/2005/1017/Vol.11/2953 dated 26.11.2013, for receipt of applications of eligible regular Class IV employees from the concerned departments. Recently, it has been seen that some of the departments are still forwarding applications of high Class of Employees for inclusion of their names in the eligibility list.
