Sir/Madam

In continuation of earlier order No. F2/TE/AD/Cont. Appt./2008/939-952 dated 04.07.2016 the extension of contract period for the following Staff w.e.f. 01.03.2017 to 28.02.2018 or till the post is filled up through UPSC whichever is earlier is approved by the Hon'ble LG, Delhi. The remuneration to be fixed for these Contractual Staff will be as suggested by Finance Department in the minimum of BP of pay Band + GP + existing/Minimum of the pay in the Level of pay Matrix of the post + @ of DA as applicable subject to signing the agreement and under mentioned terms and conditions:

- The above engagement will be up to 28.02.2018 or till the post is filled on regular 01 basis through UPSC whichever is earlier, as per the process envisaged under constitutional scheme and statutory rules. The contract will automatically terminate on 28.02.2018 (A/N)
- 02 (a)The engagement may be terminated by the Govt. at any time/stage of contract with one month written notice without assigning any reason.
  - (b) The contracted staff may discontinue the contract only after completion of the Semester either by giving one month written notice or by depositing an amount equivalent to one month Contract remuneration. The termination of agreement before the end of Semester is not acceptable.
- That the engagement is made without prejudice to the right of the 03 department/Govt. to make regular appointments by following the due process as per the Constitutional scheme and statutory rules and procedure.
- 04 The Contract Staff shall not be entitled to any benefits of Provident Funds, Pension, Gratuity, Medical re-imbursement or any other allowances/benefits available to the Govt. employees appointed on regular basis.
- The contract Staff shall take full classroom/Laboratory/Workshop/ Library load 05 as prescribed in the curriculum and any other assignment assigned by the Institute.
- 06 The contract staff will not be entitled to the Govt. residential accommodation or HRA in lieu thereof.
- 07 The engagement will not confer on the contract staff any right or claim for regular appointment to the post and the regular appointment shall be made through UPSC.
- The contract staff shall be hired on contract for full time basis for the Institute. In 08 case he/she accept any part time assignment during holidays, he/she has to seek prior approval in writing from the Principal to take such assignment, if any.
- 09 The contract staff shall be entitled for casual leave of eight days per year on proportionate basis in a Calendar year in addition to Govt. Holidays. No other leave/vacations with or without pay will be admissible unless applied by the contract staff and granted by the Govt.

10 The contract staff shall assist the institute as per the duties assigned to him/her or any other work assigned by the Institute.

11 The engagements by the Govt, neither create nor shall be deemed to create any employer/employee relation between Govt, and Contract faculty. The contract faculty shall be deemed to render services as an independent contractor/consultant.

12 The contractual staff shall submit a bill/invoice at the end of every month in respect of Services rendered by him/her during the month. Payment of Contract remuneration (fixed) shall be contingent on submission of such bill/invoice.

13 The engagement shall be strictly on contract basis only and contract faculty will not claim regularization of service on the basis of this contract.

14 The contract faculty has no right for extension/continuation of contract after 28.02.2018.

15 The contract remuneration shall remain same during the entire period of contract.

16 However, the remuneration will be paid w.e.f. the date of joining only after signing the contract agreement. Income tax as applicable will be deducted in hand by the concerned institute before the disbursal of remuneration to the contractual employees.

17 The contract staff has to sign an agreement by which the contractual staff shall indemnify the Govt. against damages suffered by the Govt. resulting directly/indirectly from the willful negligence/ default/ omission / commissions on the part of the contractual staff.

18 The Contract Staff shall sign an agreement by which the contractual Staff shall deemed to have undertake that he/she shall not interfere with the selection process for regular appointments whether by seeking suspension/termination/ quashing of the regular selection process through judicial intervention or otherwise.

19 The payment of remuneration will be directly linked to performance of teaching duties and work actually performed and no remuneration shall be payable during the vacation period. This will include the initial basic pay, DP & DA as applicable as per Govt. of India instructions.
