## OFFICE ORDER

## Sub: Distribution of funds in all Welfare and Subsidy Schemes through Aadhar based DBT

As you are aware that Government of India had already taken a decision that all the scheme funded from consolidated Fund of India are to be brought under Aadhaar based DBT. The use of Aadhaar as identifier for delivery of services/benefits/subsidies simplifies the Government delivery processes, brings in transparency and efficiency and enables beneficiaries to get their entitlements directly to them in a convenient and hassle free manner. Aadhaar obviates the need for producing multiple documents to prove one's identity. The provisions of the Aadhaar Act and Regulations under the Act have come into effect from 14<sup>th</sup> September, 2016. GOI gave guidelines to all State Governments to consider issuing notification under section 7 and/or section 57 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 for various central/State schemes making proof of Aadhaar number necessary for receipt of certain subsidies benefits and services etc.

In view of the above, various Departments of GNCTD be asked to identify schemes/ services which may be notified under section 57 of the Aadhaar Act making Aadhaar as mandatory for establishment of identify of beneficiaries and requested to forward the list of all such schemes proposed to be notified to M/o Electronics & Information Technology, Unique Identification Authority of India (UIDAI) immediately.

In this regard a meeting was also held under the Chairmanship of Chief Secretary, GNCTD on 25<sup>th</sup> July, 2016.

DTTE is also running various welfare and subsidy schemes for the welfare of the students such as Post Matric Scholarship for SC Students; Post Matric Scholarship for OBC students; Post Matric Scholarship for Minority Students; Merit scholarship to SC/ST/OBC/Minority students of Professional institutes; Merit scholarship; Merit-cum- means scholarship; vocational study scholarship etc. These schemes are implemented by various branches of the DTTE.

At present there is only three schemes viz. Post Matric Scholarship for SC Students; Post Matric Scholarship for OBC students; Post Matric Scholarship for Minority Students are linked with Aadhaar and are on NSP (2.0) and e-district portal. Remaining schemes are not linked with Aadhaar.

All the branch incharges are requested to furnish the details of the welfare schemes run by them, in the following format by <u>18/08/2017</u> so that the consolidated information could be forwarded to Finance Department, GNCTD for further necessary action at their end.
