Sub : Appeal regarding non-receipt of Information under RTI Act, 2005.

Respected Madam/Sir,

With due respect, I wish to state that *vide* my RTI Application dated 13.07.2021, which was received by the PIO (RTI) DTTE on the 15th July, 2021 vide ID NO. 5095 (copy enclosed), I had *inter- alia* sought - certified copies of - all anonymous/pseudonymous complaints received against me in the DTTE headquarter from January 2018 till July, 2021, all envelopes (both sides) containing above complaints, action taken on all such complaints, and correspondence received at DTTE headquarter from ITI Jahangir Puri in respect of those forwarded complaints.

2. In this regard, I have received response of the PIO (RTI) DTTE *vide* communication No. F.2(16)/2006/RTI/TTE/IDNo.5095/776-77/1799 dated 06/8/2021 (copy enclosed), wherein, the requisite information pertaining to only the Vigilance Branch of the DTTE headquarter has been furnished. However, information available with the Training Branch has not been furnished and instead, it has been stated that I may visit the Training Branch on any working day, at mutually agreed time, and after taking inspection of related files, obtain copies of information I find relevant on payment of requisite fees.

3. In the above context, I humbly submit the following:

- (i) As I gather, the information sought by me was required to be collected from two separate Branches of the DTTE headquarter - Vigilance Branch and the Training Branch.
- (ii) The first one - Vigilance Branch - has already furnished the requisite information. Therefore, it is clear that the information sought by me is neither vague nor hypothetical in nature.
- (iii) I have neither sought for inspection of files of the Training Branch nor have any knowledge of the files where I need to search the required information from.
- (iv) Further, there is no provision in the RTI Act wherein an applicant is required to search the requisite information himself from the records/files of a Government Department, that too when requested information is pointed and specific, like in my case.

(v) Furthermore, as per my limited knowledge of the RTI Act, no other provision of the said Act attracts and justifies this apparent denial of information by the Training Branch.

4. In view of the above, I request your goodself to intervene here to protect my rights and direct the Training Branch to furnish all relevant information cited afresh in para 2 above. I further reiterate before your goodself that the Training Branch may be directed to also provide **the certified copies of envelopes containing the said complaints.** I humbly submit that, as per my knowledge, envelopes are invariably kept by all Government departments with the received communications for record purpose, and as can be seen, the Vigilance Branch of DTTE headquarter has already provided me the same along with other information in this case.

5. Further, I request your goodself to direct the Training Branch to provide the remaining information pending with them, **free-of-cost**, to me as per the provisions of the RTI Act.
