**Detail of RTI Application:-**

I had filed an application under RTI Act 2005 on 23-06-2022, (Annexure A-1) and aggrieved from the reply vide F.2(16)/2006/RTI/TTE/ID No. 2517/837-38/3855, Dt. 06.07.2022, (Annexure A-2) The PIO supply the document as Reply to My RTI Application, supplied by Dr. Dipti Mal, Deputy Director (SB), which is nothing but a mockery of the Act.

**Ground for Appeal/ Grievances:-**

1. That PIO has supplied the information without going through the content of the reply by Dr Dipti Mal via letter No. F.2 (16)/2006/RTI/TTE/ID No. 2517/837-38/3855, Dt. 06.07.2022. The said letter given in answer/reply to my RTI application dated 24.06.2022 is baseless and irrelevant.
2. That I have been requested to visit the office to inspect the file and deposit fee to get the sought information after taking time.
3. That as per the letter I, went to his office on 14.07.2022 at about 2:30 pm Dr. Dipti Mal for taking time, but he was not available then I went to Brach to meet Mr. Jitender, he also informed me that Dr. Dipti Mal is not there and file is also with him only. He also called me on Monday and asked that I should come to the office. Later, when I called him, then he informed me that the file will come after a month as it has gone to Hon'ble LG for final order. If this is a true statement, then why did Dr. Dipti Mal ask me to visit the office after

taking time and then inspect file earlier? This is nothing, but he has evolved a method to give every possible shelter to Dr. B.S. Chauhan to make a mockery of the RTI Act that he does frequently.

**Analysis of the Reply of the PIO:-**


1. That, in reply to point no. -1, asks me to visit the office to inspect the file, but when I, reached there to do the same as per their direction only, Dr. Dipti Mal was not available in his office. Then I went to branch for the same and the dealing hand Mr. Jitender also said the same that Dr. Dipti Mal is not available hence, you call me on Monday and then only you can come.

2. That, 18/07/2022 I called Mr. Jitender, he informed me that file is not in the branch it has gone to Hon'ble LG for final decision and it will reach back in the branch in a month or two, after that only I'll be able to inspect the file. This statement of the dealing hand is nothing but a harassment tactic because if he already knew that the file is not in the branch then how come Dr. Dipti Mal requested me to visit the Office for inspection of file. This act clarify the inaction of the Branch, specially dealing hand and Dr. Dipti Mal or that they are taking the act very causally and are not afraid to make a mockery of the RTI Act.
3. That in point no-2 Dr. Dipti Mal has said the information cannot be supplied under Rule 8 of RTI Act as "Under Section 8(1) (i), RTI Act, 2005 that cabinet Papers including records of deliberations of the council if Ministers, Secretaries and other officers: Provided that decisions of Council of Ministers the reason thereof, and the material on the basis of which the decision were taken shall be made public after the decision has been taken, and the matter is complete, or over: Provided further that those matters which come under the exemptions specified in this section not be disclosed." **The said clause clearly stated that the material on the basis of which the decision were taken shall be made public after the decision has been taken, and the matter is complete.** The decision has already been taken by the cabinet regarding the merger of the college and joined Director Dr. O. P. Shukla has sent the letter to AUD and College of Art regarding the Admission for the session of 2022-23 in AUD, which suggests that Ministers and Department have completed the process, and material shall be made public.

#### Prayer

As explained above, kindly direct the PIO to supply the correct and true information as per my RTI Application dated 23.06.2022, also direct Dr. Dipti Mai not to harass in the preview of RTI Act, and supply the factual and true information.




