**ORDER**



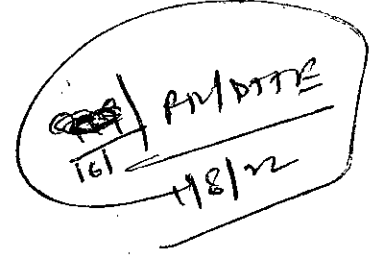

**Detail of RTI Application:-**

I had filed an application under RTI Act 2005 on 25-05-2022, (Annexure A-1) which was further transferred to PIO DTTE & PIO CS office and aggrieved from the reply vide F.2 (16)/2006/RTI/TTE/ID No. 5213/783-84/3176, Dt. 30.06.2022, (Annexure A-2) The PIO supply the document as Reply to My RTI Application, supplied by Dr Dipti Mal, Deputy Director (SB), vide No. F.1 (274)/RTI/SB/DTTE/2021/940-41 date 24.06.2022 which is nothing but a mockery of the Act.

**Ground for Appeal/ Grievances:-**

1. That PIO without going through the content of the reply of Dr Dipti Mal's letter No F.1(274)/RTI/SB/DTTE/2021/940-41 date 24.06.2022 that the said letter/document if giving the answered/reply or not to my RTI application dated 25.05.2022. The said reply is baseless, irrelevant, misleading, false and fabricated.

#### Analysis of the Reply of the PIO:-


1. That in point no-1 I, asked the file noting of letter date 19.04.2022, but instead of supply the same Dr Dipti Mal informed me that matter is subjudice in Hon'ble CAT. It is worth mentioned here that in this order neither I, find file noting of the above said letter nor the said case is anyways based to my sought information. The said reply is either a mockery of the RTI Act or he fails to understand the quarry, because the file noting's are always lying in the office not in the courts, also the said notings were not fall in the preview of rule 8 of RTI Act.
2. That in point no-2 I, asked the file noting's, but instead of supply the same Dr Dipti Mal gave identical reply to this point of as (point no-1). Further regarding the immediate step down of Dr B S Chauhan from the post of Offg. Principal matter is subjudice vide O A No 1550/2022, interestingly the subject matter of the said OA is not in any way related to my sought information, because the said case is pending for deciding the seniority, not for the step down of Sh B S Chauhan, hence the file noting of this letter is necessary for me so that the action or inaction of the department can bring forwarded further to the Lt Governor for appropriate action.
3. That in regard to point no-3, I saw the order of Hon'ble High court in W.P No 6739/2022. It is worth mentioned here that in this order neither I, find file noting of the above said letter nor the said case is anyways related or based on the said notings, as the case is for starting the admission in the College of Art. Hence Dr Dipti Mal Purpose fully supply the wrong and false and fabricated information to sought information which is nothing but he finds a way to hide his incapability to handle/deal with this questioned letter. If the said letter was dealt with letter and spirit then file noting must be there and truth will definitely come out in front of everyone including Lt Governor of GNCT of Delhi, that Sh B S Chauhan is illegally holding the charge of Officiating Principal of the College of Art.

4. That in regard to point no-4, again Dr Dipti Mal supplied the information that matter is subjudice in Hon'ble High court vide W.P (C) No 6739/2022. It is worth mentioned here that the above said letter neither the part of the case nor the said case is related/based on the sought notings, the above said case is for starting the admissions of BFA & MFA which were not done By the Sh B S Chauhan for the session of 2021-2022 in the College of Art. Hence Dr Dipti Mal Purpose fully supply the wrong, false and fabricated information toward sought information, which is nothing but he trying to finds a way to hide the conspiracy and misleading correspondences that to without approval of Hon'ble Lt Governor of GNCT of Delhi through which Officials of DTTE manage to get interim order from Hon'ble High court that "admission process will be start as part of AUD". If the said letter was dealt with letter and spirit then truth will definitely come out in front public at large including Lt Governor of GNCT of Delhi and hon'ble High Court too, that how the officials of DTTE misleading the Hon'ble High court, Hon'ble Lt Governor and Other Decision making authorities of GNCT of Delhi.

As explained above, kindly direct the PIO to supply the correct and true information as per my RTI Application dated 25.05.2022 which was transferred to DTTE, also direct Dr Dipti Mal that he bound to supply the factual and true information not the false and fabricated one which not better than the harassment of information seeker.
