NOTIFICATION

In exercise of powers conferred under clause (xix) of Section 6 of the Delhi Skill and Entrepreneurship University Act, 2019 (Delhi Act 04 of 2020), the Government of NCT of Delhi vide Cabinet decision No.2955 dated 2nd March 2021 has approved the proposal for merger/integration of 10 Government Institutes of Technology (formerly, known as Polytechnics) as per **Annexure-1** into the Delhi Skill and Entrepreneurship University (DSEU) for all academic and certification purposes. The Cabinet has also decided to transfer all movable assets of the 10 Government Institutes of Technology to DSEU on "as is where basis".

The Hon'ble Lt. Governor of Delhi is pleased to accord permission for transfer of 666 sanctioned posts of Group A teaching posts (11 in BPIBS and 655 in ITs) and 421 sanctioned posts of Group C (Non-Teaching posts) to the DSEU on the existing terms and conditions as per **Annexure-2** and **Annexure-3**.

Hon'ble L.G. is further pleased to allow the "right to use" of all the existing buildings of these Institute of Technologies to the University (DSEU) with the responsibility of proper upkeep and maintenance of these assets.



Terms and condition related to existing faculty and staff of the 10 Institute of Technology

1. The regular staff members of Institute of Technology including Principal/Faculty/officers/Support staff will be given an option to adopt the service conditions of DSEU or to continue their services on same terms and conditions on which they were appointed. In case they opt for later, they would be treated as being on deemed deputation to the DSEU and continue to be governed by the existing service rules.

2. It is also approved that the teaching faculty of these Institutes of Technology shall be re-designated suitably (ie. As Assistant Professor/Associate Professor and Professor etc and Principals as Director).

3. Contractual faculty and other contractual Non-Teaching Staff working in these Institutes of Technology will continue in DSEU on the existing terms and conditions till the completion of their contract. Thereafter, DSEU would be free to take a decision regarding their further engagement/disengagement.

The faculty/officers /staff who are working either in diverted capacity or on deputation in these institutions from different Departments/Institute of GNCTD, will be reverted to their parent cadre. In case, the services of any faculty member(s)/officer/staff is required by the University (DSEU), it can make a fresh request in this regard to the concerned Department/Institute.
