





Subject:- RTI applications received by a public authority regarding information concerning other public authority/authorities.

The undersigned is directed to refer to this Department's OM of even number dated 12th June, 2008 on the above noted subject, clause (iii) of para 3 of which provides that if a person makes an application to the public authority for information, a part of which is available with that public authority and the rest of the information is scattered with more than one other public authorities, the Public Information Officer (PIO) of the public authority receiving the application should give information relating to it and advise the applicant to make separate applications to the concerned public authorities for obtaining information from them. It further provides that if no part of the information is available with the public authority receiving the application but scattered with more than one other public authorities, the PIO should inform the applicant that information is not available with the public authority and that the applicant should make separate application to the concerned public authorities for obtaining information from them.

2. The matter has been examined in consultation with the Chief Information Commissioner, Central Information Commission and it has been decided to advise the PIOs that if the details of public authorities who may have this information sought by the applicant are available with the PIO, such details may also be provided to the applicant.

Applicants want following information under the above said Act for:-

1. That vide DGNT Letter bearing No.(DGT)-19/03(02)/2022-CD dated 05.04.2022, Additional Secretary/Director General Sh. Atul Kumar Tiwari (IAS) has with subject simplification of Workshop Calculation and Science (WCS) and Engineering Drawing (ED) syllabus of maximum 40 hours each and merging with Trade Theory Subject for all engineering Trades. Applicable for current session also. Thus students will not appear for separate ED/WCS examination in July-August, 2022 examination -Reg.
2. That with reference to above noted subject please clarify whether the Craft Instructor of respective subjects will be merged in the same ITI/Department on the post of Craft Instructor or they will be retrenched, provide the copy of that norms/circular regarding fate of above noted Craft Instructor.
3. That also requested to provide the copy of departmental and Ministerial Communication regarding the fate of above noted Craft Instructors.
4. That also provide the number of Craft Instructors of above noted subjects working in different ITIs in the State of Delhi.
5. That since the examination of the same is avoided from this year itself so kindly inform how many Craft Instructors are becoming surplus gave the number and name of such instructors.
6. That since new recruitment of Craft Instructor of above noted subjects have been made, kindly tell the fate of such candidates and also gave the name and number of such candidate.
7. That kindly provide the copy of letter/order vide which fate of the Craft Instructor working on contract basis for the last ten years or more on the above noted subject will be decided and also clarify how many Craft Instructors working on contract basis are affected in the State of Delhi.

It is therefore, requested that information may kindly be supplied with in 48 hours after the receipt of this application because issue of life and liberty.
